

# Supplementary Regulations – Motorcycles (ACU)

## 1. Announcement

CVMRC Jersey will organise and promote Restricted Speed Interclub Motorcycle held under an ACU Permit at Victoria Avenue on 5<sup>th</sup> June of 2026.

Event dates, venue details, permit numbers and start times will be published in the Final Instructions.

---

## 2. Jurisdiction

The meeting will be governed by the National Sporting Code of the Auto Cycle Union (ACU), these Supplementary Regulations, and any written instructions issued by the organisers.

---

## 3. Eligibility

All Entrant must hold a valid ACU Competition Licence. One Day Licences will be available to competitors who wish to use this on the day of the event.

- Competitors must meet the minimum age of 12 - 15 years of age to compete. Such competitors will be restricted to 85cc Machines.
- 16 year old competitors are restricted to 125cc machines.

- Competitors under 18 years of age must be accompanied by a Parent or Legal Guardian, who must attend signing-on and remain available for the duration of the meeting.

It is CVMRC rule that Jersey competitors will be permitted to compete whilst disqualified from holding or obtaining a driving licence where such disqualification applies.

## 4. Entries

Entries must be submitted via the official online entry system (Rallies.info) and received by the published closing date, complete with the appropriate fee. An entry not accompanied by the correct fee will be deemed null and void.

Event entry fee is: £118

Late entries may be accepted up to 5 days before the event at the organiser's discretion with a £40 penalty payment.

33% of the entry fee may be retained if an entry is cancelled or withdrawn up to 10 days prior to the event, 50% if the entry is cancelled or withdrawn 3 days before and 100% of the entry if cancelled or withdrawn on the date of the event, with no prior notification.

The organisers reserve the right to disqualify at any time during an Event any Licence Holder or other Person connected with the Entrant considered as possibly unfit by reason of health consumption of alcohol or prohibited substances, any competitor found smoking and / or using electronic alternatives whilst participating in the Competition and any person convicted at Law of an offence committed during the Event.

Entry numbers will be set by the Organisers of a minimum of 80 and a maximum of 110 for both ACU and Motorsport UK competitors.

Double entries will only be accepted if the maximum number of entries are not reached. They will be placed on a reserve list and notified if successful 5 days prior to the event.

## 5. Officials

Officials of the meeting, including the Clerk of the Course, Stewards, Technical Officials, Timekeepers, Secretary of the Meeting and Safeguarding Officer, will be named in the Final Instructions.

## 6. Insurance

All competitors will be insured in accordance with ACU Personal Accident and Third Party Insurance provisions whilst practicing and competing.

The organisers will not be held liable for damage to vehicles required to be removed from the course during the meeting.

The club undertakes to ensure each competitor, indemnify him / her against third party claims made arising out of the event competing in both in practise and official runs. Excluding claims by other competitors, entrants, spouse, or mechanic.

## 7. Classes

Motorcycle classes are defined in accordance with ACU Hill Climb regulations and are grouped to mirror the structure used for car events, providing consistency across CVMRC Jersey competitions.

The organisers reserve the right to amalgamate classes where necessary to ensure viable competition.

## **Modern Classes**

### **Solo Motorcycles – Road-Going / Production**

- M1 Up to 250cc
- M2 251cc to 500cc
- M3 501cc to 750cc
- M4 Over 750cc

### **Solo Motorcycles – Modified / Special**

- M5 Up to 500cc
- M6 501cc to 750cc
- M7 Over 750cc

## **Racing Motorcycles**

- M8 Racing Motorcycles up to 250cc
- M9 Racing Motorcycles 251cc to 500cc
- M10 Racing Motorcycles 501cc to 750cc
- M11 Racing Motorcycles over 750cc

## **Historic Classes**

Historic motorcycles must comply with ACU technical regulations applicable to their period.

Historic classes are defined by Date of Manufacture (DOM) as follows:

### **Historic bikes manufactured before 31/12/1970**

- H1 Road-Going / Production
- H2 Modified / Special
- H3 Racing Motorcycles

### **Post-Historic bikes manufactured from 31/12/1970 to 31/12/1994**

- MH4 Road-Going / Production
- MH5 Modified / Special
- MH6 Racing Motorcycles

Eligibility must be declared at the time of entry. The organisers reserve the right to reassign any motorcycle to an alternative class where appropriate.

## **8. Timing**

Timing will be by electronic means using approved timing equipment.

---

## **9. Starting**

Starts will be from a standing start with engines running. A competitor will be deemed to have started once the timing beam has been broken. Competitors will be shown a green sign with the word Go to start. In the case this does not work, we will use a green flag.

Only competitors and officials are permitted in the start area.

---

## **10. Course**

The course will be a temporary closed-road course, licensed for competition. Course length and licence numbers will be:

Victoria Avenue Sprint: 402 Metres

---

## **11. Technical Regulations**

All motorcycles must comply with ACU technical regulations for Hill Climbs.

- Motorcycles designed specifically for grass track or sand racing are not permitted.
- Methanol-fuelled machines must use an additive to provide a visible flame and must be clearly identified.

- Noise limits will be enforced in accordance with ACU regulations.
- Protective clothing must be worn as required by the ACU, including mandatory spinal protection.
- Tyre Warmers are allowed.

Rear wheel spinning is only permitted in designated tyre-warming areas. Breach of this rule may result in disqualification.

---

## **12. Programme of Events**

The programme of the day, including practice runs, competition runs, lunch breaks and finish times, will be published in the Final Instructions.

---

## **13. Licences**

All competitors must hold a valid ACU Competition Licence appropriate to the event.

Club Membership cards must also be produced.

Where permitted, One Event Licences will be available and must be applied for via the official entry system.

---

## **14. Technical Control, Noise Testing and Signing-On**

All machines and required riding equipment must be presented for technical inspection at the time and place stated in the Final Instructions.

Failure to present equipment correctly or at the required time may result in a penalty.

Competitors must sign on with valid club membership and licence documentation.

The Noise Test Official is deemed a Judge of Fact for noise.

---

## **15. Numbers and Sponsors' Decals**

Competition numbers must be displayed in accordance with ACU regulations. No tape may be used as a substitute.

Any mandatory decals supplied by the organisers must be displayed throughout the meeting.

---

## 16. Practice

The course is normally a public road and is closed for competition under the relevant local legislation.

Unauthorised practice on the course is **strictly prohibited** and will result in exclusion from the event and/or future club events.

During the event there will be 1 practice run per competitor prior to any Official timed runs commencing.

---

## 17. Method of Running

Any machine involved in an incident must be re-examined by a Technical Official before continuing.

---

## 18. Finish

Competitors must reduce speed immediately after the finish line. On either side of the track there will be marker boards showing 75, 50 and 25 metres. By the 25 Meter board, competitors must be traveling at no more than 10mph. Follow marshal instructions at all times.

---

## 19. Flag signals

If a flag signal or red light is shown to a competing vehicle, they must stop and await further instruction from the course marshals.

---

## 20. Disqualification

The organisers reserve the right to disqualify any competitor for breach of these regulations or the ACU National Sporting Code.

Entry fees will not be refunded in the event of disqualification and exclusion from future events will be at the discretion of the committee.

---

## **21. Fuel and Fire Extinguishers**

Fuel handling and fire extinguisher requirements must comply with ACU regulations.

Each working vehicle in the paddock must have access to a minimum 2kg dry powder fire extinguisher.

---

## **22. Paddock and Pit Area**

- No smoking or vaping in the paddock or pit area
  - Environmental mats are mandatory beneath all competition machines
  - Riding in the paddock is restricted to access to and from the start and return roads only
- 

## **22. Abandonment**

The organisers reserve the right to postpone or abandon the meeting. Refunds, where applicable, will be issued:

33% of the entry fee may be retained if an entry is cancelled or withdrawn up to 10 days prior to the event, 50% if the entry is cancelled or withdrawn 3 days before and 100% of the entry if cancelled or withdrawn on the date of the event, with no prior notification.

---

## **23. Results**

Results will be published at the venue and via official online channels.

---

## **24. Awards**

No awards are presented at the event but all times are recorded.

---

## **25. Interpretation**

The interpretation of these regulations rests solely with the Stewards of the Meeting, subject to the ACU National Sporting Code.

---

## **26. Marshals and Event Support**

Marshal and event support requirements will be published in the Final Instructions. Failure to comply may result in penalties or refusal of entry.

---

## **27. Generators**

All generators must be fitted with a functioning RCD.
