## 1. Announcement

CVMRC Jersey will organise and promote Sprint on 5<sup>th</sup> of June 2026.

---

## 2. Jurisdiction

This meeting will be held under the National Competition Rules of Motorsport UK

[www.motorsportuk.org](http://www.motorsportuk.org) (incorporating the provisions of the International Sporting Code of the FIA), and these Supplementary Regulations.

---

## 3. Eligibility

**Interclub entrants:** Competitors must hold an Interclub Speed Licence (minimum) or equivalent issued by Motorsport UK.

**Karting entrants:** Competitors must hold a National Kart Licence (minimum) or equivalent issued by Motorsport UK. All kart competitors must be over the age of 16 years.

Events are open to fully elected, paid-up members of the CVMRC as the organising club and our invited clubs: The Midland Auto Club (MAC), Jersey Old Motor Club, Austin Healey

Register, Aston Martin Owners Club, MG Owners club, Guernsey Motor and Light Car Club, Guernsey Kart & Motor club, JMC & LCC, Porsche Owners Club & Jersey Kart & Motor Club. 750 Motor Club Ltd. Austin Healey Motor Club Ltd. Bentley Drivers Club Ltd. Bugatti Owners Club Ltd. Historic Sports car club. Jaguar Drivers Club. Lagonda Club Ltd. Morgan Sports car club Ltd. Vintage Sports car club Ltd. Veteran Car Club. Triumph Register. Woolbridge MC & MG car Club. The Guernsey Rally LBG. ACSMC. ASWMC. Gilbern Owners Club.

No competitor will be permitted to compete whilst disqualified from holding or obtaining government issued a driving licence wherever issued. This is also a CVMRC Club rule

## 4. Entries

Entries must be submitted via the official online entry system (Rallies.info) and received by the published closing date, complete with the appropriate fee. An entry not accompanied by the correct fee will be deemed null and void.

Event entry fee is: £118

Late entries may be accepted up to 5 days before the event at the organiser's discretion with a £40 penalty payment.

33% of the entry fee may be retained if an entry is cancelled or withdrawn up to 10 days prior to the event, 50% if the entry is cancelled or withdrawn 3 days before and 100% of the entry if cancelled or withdrawn on the date of the event, with no prior notification.

The organisers reserve the right to disqualify at any time during an Event any Licence Holder or other Person connected with the Entrant considered as possibly unfit by reason of health consumption of alcohol or prohibited substances, any competitor found smoking and / or using electronic alternatives whilst participating in the Competition and any person convicted at Law of an offence committed during the Event and report such Motorsport UK 2025 National Competition Rules Chapter 3 Appendix 11.

Entry numbers will be set by the Organisers of a minimum of 80 and a maximum of 110 for both ACU and Motorsport UK competitors.

Double entries will only be accepted if the maximum number of entries is not reached. They will be placed on a reserve list and notified if successful 5 days prior to the event.

## 5. Officials

## 6. Insurance

All competitors will be covered by Personal Accident and Competitors' Third Party Insurance whilst practicing and competing. CVMRC Jersey and/or its agents will not be held liable for any damage caused to vehicles required to be removed from the course during an event.

### **Modified Series Production Sports Cars**

- C5 up to 1400cc
- C5.1 1401 to 2000cc
- C5.2 2001cc and over

### **Modified Specialist Production Cars**

- C6 up to 1400cc

- C6.2 2001cc and over

### **Sports Libre Cars**

- C7 up to 1400cc

## **8. Timing**

Timing will be by electronic light beam. Timing struts are mandatory for all vehicles and must be fitted to the foremost part of the vehicle in accordance with Motorsport UK regulations.

Failure to comply may result in the competitor not being timed.

## **9. Starting**

Starts will be from a standing start with engines running unless otherwise stated in the Final Instructions.

Starts will be from a standing start with engines running. A competitor will be deemed to have started once the timing beam has been broken. Competitors will be shown a green sign with the word Go to start. In the case this does not work, we will use a green flag.

Starting procedures will be in accordance with Motorsport UK NCR Chapter 14.

## **11. Technical Regulations**

All vehicles must comply with Motorsport UK technical regulations for Hill Climbs and Sprints.

Noise testing will be undertaken in accordance with the current Motorsport UK Yearbook.

Vehicles running on methanol must include an additive that provides a clearly distinguishable colour and smell when burning. Such vehicles must display a dayglo orange disc of 3-inch diameter immediately adjacent to the competition number on both sides of the vehicle.

Slick tyres are prohibited unless expressly permitted under Motorsport UK regulations.

Tyres must comply with Motorsport UK permitted lists (including List 1A and 1B where applicable) or relevant period regulations. Post-war vehicles may be required to run treaded tyres in accordance with Motorsport UK regulations.

Tyre warming is permitted only in designated areas, with forward motion maintained at all times.

Only original manufacturer wheel sizes are permitted, subject to Motorsport UK tolerances, unless otherwise stated in the Final Instructions.

## **12. Programme of Events**

There will be one practice run followed by at least 2 official runs or however many that can fit within the road closure time

---

## **13. Licences**

A valid competition licence must be produced at signing-on by all competitors along with your club membership card.

---

## **14. Scrutineering, Noise Testing and Signing-On**

Scrutineering, noise testing, and signing-on will take place at times and locations specified in the Final Instructions.

All vehicles must be presented in a clean and tidy condition with competition numbers fitted.

The organisers reserve the right to penalise any competitor not ready for scrutineering, noise testing, or signing-on at the required time.

Scrutineers are Judges of Fact for all matters relating to vehicle safety, eligibility, and compliance.

## 15. Numbers and Sponsors' Decals

Competitors must display correct competition numbers and any required organisers' decals throughout the meeting.

---

## 16. Practice

Competitors will be given a minimum of one practice run, subject to Motorsport UK regulations and the event timetable.

Practicing outside official times is **strictly prohibited**.

Unauthorised practice on the course is **strictly prohibited** and will result in exclusion from the event and/or future club events.

During the event there will be 1 practice run per competitor prior to any Official timed runs commencing.

---

## 17. Method of Running

Any vehicle involved in an incident must be re-examined by a scrutineer before continuing.

---

## 18. Finish

Competitors must reduce speed immediately after the finish line. On either side of the track there will be marker boards showing 75, 50 and 25 metres. By the 25 Meter board, competitors must be traveling at no more than 10mph. Follow marshal instructions at all times.

---

## 19. Exclusion

The organisers reserve the right to exclude any competitor for breach of these regulations or Motorsport UK regulations.

Entry fees will not be refunded in the event of disqualification and exclusion from future events will be at the discretion of the committee.

---

## **20. Fuel and Fire Extinguishers**

Fuel handling and fire extinguisher requirements will be in accordance with Motorsport UK regulations.

---

## **21. Pit Area**

Smoking, including electronic alternatives, is strictly prohibited in the pit and paddock areas.

A minimum 2kg fire extinguisher (foam or dry powder) must be available in each pit area where fuel is present.

Only competition vehicles and authorised personnel are permitted in the pit area. All competitors must comply with marshal instructions at all times.

---

## **22. Abandonment**

The organisers reserve the right to postpone or abandon an event if necessary. Refunds, if applicable, will be in accordance with the terms published in the Final Instructions.

---

## **23. Results**

Provisional and final results will be published as advised in the Final Instructions.

---

## **24. Awards**

No awards are presented at the event but all times are recorded.

---

## **25. Interpretation**

The interpretation of these regulations rests with the Stewards of the Meeting, subject to Motorsport UK regulations.

All signed-on officials and marshals will be deemed Judges of Fact in respect of driving behaviour, tyre warming, noise, and safety compliance.

---

## **26. Trailers**

Trailer use must comply with applicable road traffic legislation and not be kept in the pits for the duration of the event. Details on trailer parking will be detailed in the final instructions.

---

## **27. Marshals and Event Support**

Competitors may be required to assist with event operation, including marshalling or other duties, as a condition of entry. Requirements will be detailed in the Final Instructions.

All competitors and entrants must comply with Motorsport UK Safeguarding Policies and Codes of Conduct.

No competitor should leave the event prior to the conclusion without permission from the Clerk of the Course.
